Anthony Callisto, Jr.

Biography

Anthony Callisto, Jr. is a criminal justice, safety and security, organizational development, and labor relations consultant. He retired in June of 2021 as the Senior Vice President for Safety and Chief Law Enforcement Officer for Syracuse University (SU) where he provided executive leadership to nearly two-hundred full time campus peace officers, security officers, communications officers, environmental health and safety specialists, risk management professionals, fire and life safety officers, emergency managers, parking and transit officials and administrative staff in the Syracuse University Division of Campus Safety and Emergency Services. He was promoted to this position in December of 2014. Prior to the promotion, he was the Chief of Public Safety for Syracuse University, leading the third largest law enforcement agency in Onondaga County which provides patrol, investigations, crime prevention and emergency communications service to over 22,000 fulltime undergraduate and graduate students and the Syracuse University Community. The department responded to over 70,000 calls for service in 2020. He was appointed at SU in January of 2006, upon retiring as the Chief Deputy for the Onondaga County Sheriff's Office where he was employed for 25 years and led the administration and operation of the Onondaga County Justice Center jail. He was appointed as Chief Deputy in 1996 and managed over 300 staff and annual budgets up to \$ 40 million. He is a past president of the Central New York Association of Chiefs of Police, the American Jail Association, the Food Bank of Central New York. From 1992 through 1996, as a sheriff's lieutenant, Chief Callisto coordinated the \$53 million transition from the old Public Safety Building Jail to the Onondaga County Justice Center. Callisto is an expert in criminal justice management and operation, program development, incident investigation, prisoner transportation, building and event security, facility design and technology, new facility transition and campus community policing. Callisto is certified by the New York State Division of Criminal Justice Services as a police and corrections instructor and has instructed in hundreds of hours of recruit academy training sessions, in-service training classes, training for sheriffs, corrections and police departments in New York State, and the American Jail Association. He is currently the chair of the training committee of the Central New York Association of Chiefs of Police. He was a consultant for the United States Department of Justice, National Institute of Corrections and the American Jail Association and he is a former Contributing Editor for Corrections Manager's Report. He has written over twenty published articles related to criminal justice topics and co-authorized one peer reviewed book. In addition to law enforcement experience, Callisto has been a consultant and trainer under Dr. Neil Katz for the Executive Education Program at Syracuse University's Maxwell School of Citizenship and Public Affairs. His consulting work includes assessments, interventions and training for various state and federal agencies in the areas of Conflict Resolution, Interest Based Negotiation, Mediation, Communication Skills, Labor Relations, Management and Leadership. Callisto holds a Bachelor of Arts in Criminal Justice from Columbia College and a Master of Arts in Public Administration at Syracuse University's Maxwell School of Citizenship and Public Affairs.
